During the year under review, all three medals, Gold Medal, Silver Medal and Bronze Medal were awarded to BSN students of the Patel Institute of Nursing and Allied Health Sciences who secured First, Second and Third position in the examination held by the Dow University of Health Sciences in the year 2019. It is worth mentioning that couple of years ago Patel Institute of Nursing and Allied Health Sciences had only 40 students which number has increased to 350 students in the year 2019. By the grace of Almighty Allah, during the year under review, the institution posted robust financial results coupled with stable performance on operational front. Operating expenses increased in line with increased in revenue. We have managed to achieve the highest ever revenue in the fiscal year 2018-19.

We look forward to maintain and manage operational cost by exercising vigilance on operational spending. Operational cost is constantly reviewed so as to reduce the same on a sustainable basis. Operational cost efficiency is the prime focus of our strategy. At the same time it is also difficult to control the increasing in cost of providing high quality healthcare and absorb the increasing inflation rates as a consequence, we have to adjust our cost of services.

We continuously strive to improve efficiency by utilizing all available resources. This year we have achieved growth in performance despite prevailing inflation and price hike that also affect the healthcare institutions and we are not exception of it.

Statistics of medical services provided by the hospital during fiscal year 2018-19 as compared to the year 2017-18 is presented in the following table.

During the year under review, we collected a sum of Rs.118.199 million in the Zakat Fund as against Rs. 80.306 million in the immediately preceding year. In the current year medical assistance amounting to Rs. 105.862 million was provided to the destitute patients from Zakat Fund as against Rs. 84.202 million in the previous year.


Financial performance for the year fiscal 2018-19 reveals that hospital made net profit of Rs.29.080 million during the year 2018-19 as compared to net profit of Rs. 26.943 million in the immediately preceding year 2017-18. Net profit is mainly attributable to improvement in performance and cost reductions. 16.08% growth in revenue was achieved in the year under review as compared to the preceding year 2017-18. We have upgraded our Information Technology System by implementing Oracle Financials to strengthen procurement, payment and financial reporting process.

During the year 2018-19 employees were paid compensation and benefits amounting to Rs. 529.578 million as compared to Rs. 462.896 million in the year 2017-18. We are obliged to retain our nursing and technical staff by aligning their compensation and benefit structure with the prevailing market practices. We are taking

all appropriate measures for increase in revenue, decrease in operational cost and strengthen financial stability of the hospital.

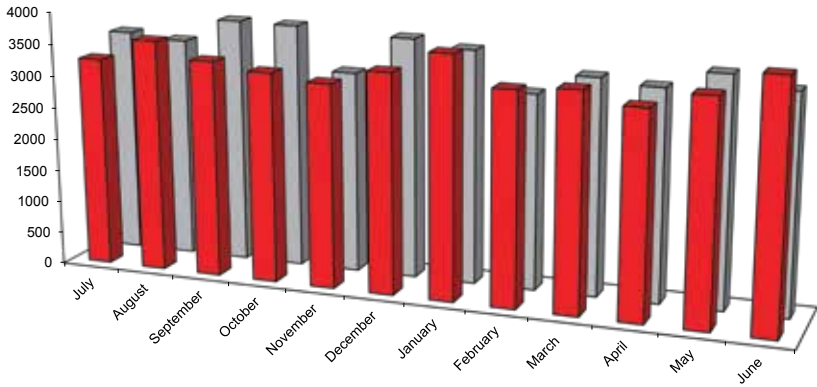
To ensure sufficient availability of funds, we have an effective cash flow management system in place whereby cash inflows and outflows are projected on a regular basis and rigorously monitored. Current working capital requirements are adequately financed through internal cash generation without recourse to any external financing. During the year under review net cash generated from hospital's operating activities amounted to Rs. 59.172 million as compared to Rs.84.570 million in the preceding year 2017-18. Having effective financial management system, the available surplus liquidity is being effectively channelized into planned projects to generate further revenue.

We express our deep gratitude to all our donors, associates and well wishers for their continued financial support and generous contribution for the noble cause. Such considerations have enabled us to add yet another successful year in the Patel history. We look forward to their continuous financial support and generous contribution in the ensuing year 2019-20. 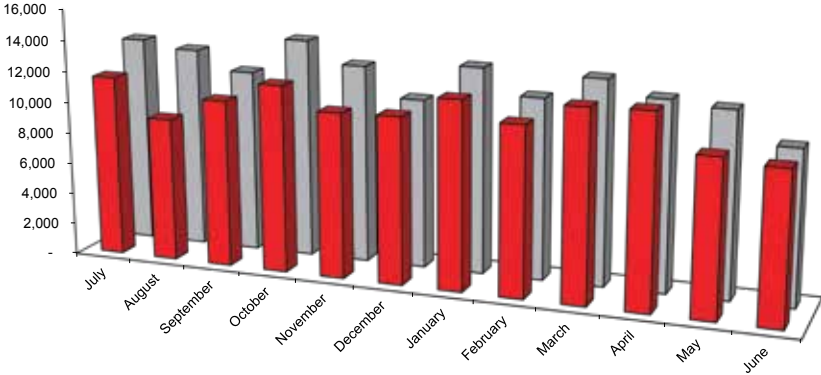

### EMERGENCY VISITS



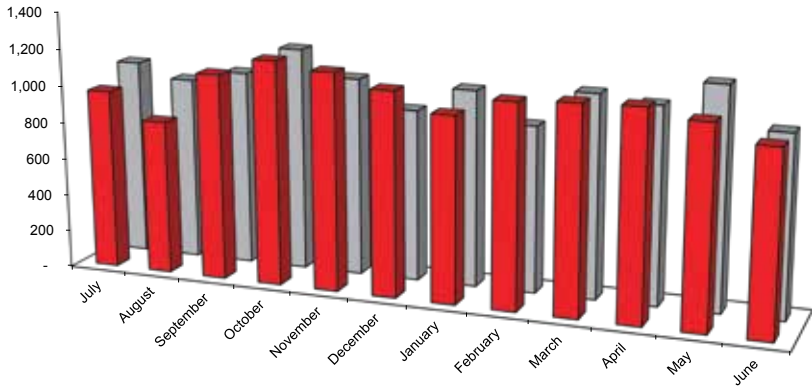

### OPD VISITS



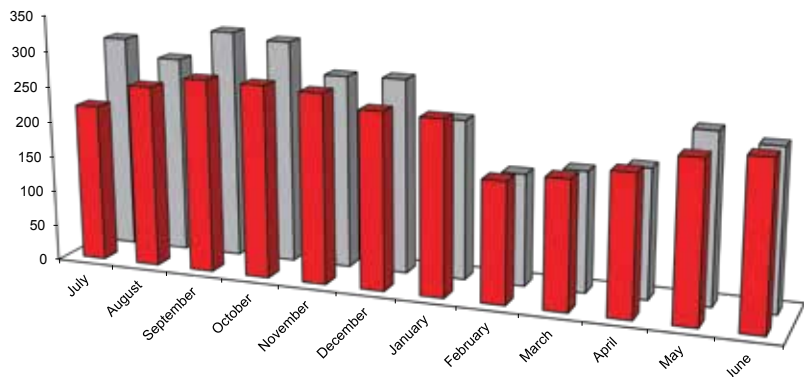

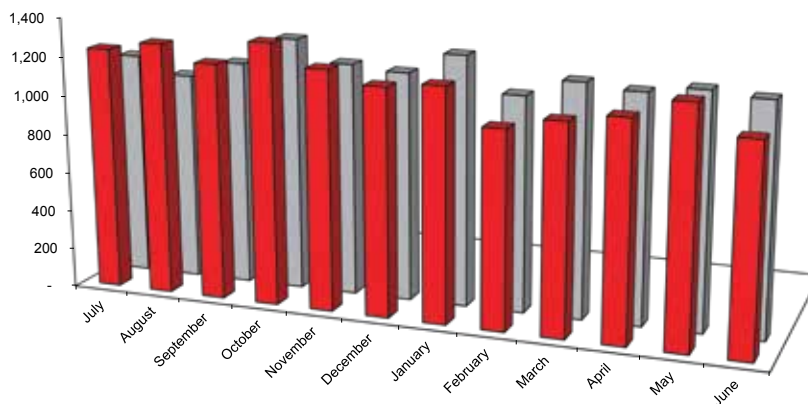

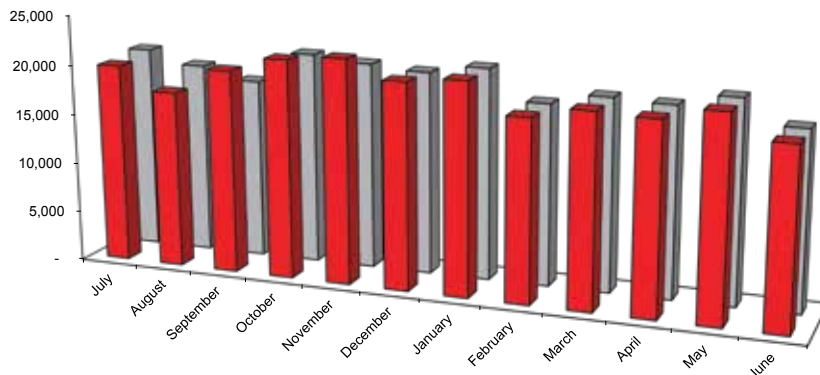

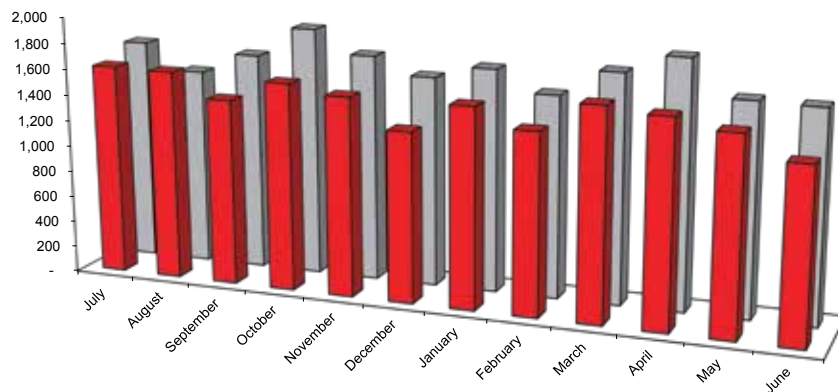

# OUR SERVICES



## AUDIOLOGY

The department of Audiology provides services six days a week from 3:00 pm to 7:00 pm, under the supervision of a specialized technician. The team caters variety of services offered under the umbrella of Audiology department that includes Hearing Assessment / Screening, speech discrimination, pure tone audiometry and Tympanometry.



## BURN UNIT

We provide Burn Care for all extremes of life i.e. from infant to old. The burns team have dedicated, qualified and experienced plastic and burn surgeon, who offer patient with the best variety of care. Treatment of burn is basically a team work and comprises of highly professional skills and dedication. Our services are functional 24/7 with 10 beds dedicated Burn ICU, well equipped Burn OT and exclusive step down unit for Burn patients. We are dealing with acute burns as well as burn complications from all parts of the country.



## CENTRAL STERILE SUPPLY DEPARTMENT (CSSD)

Highly focused on consistent workflow maintenance which includes decontamination, assembling and packing, autoclaving, sterile storage and distribution, all these processes are done in accordance with our quality standards. Internships are also provided to the upcoming and young professionals in this department.



## RADIOLOGY SERVICES

Our Radiology services include general and Special radiography, fluoroscopy, ultrasound color doppler, CT Scan, interventional radiology (vascular and non-vascular intervention), OPC, mammography, ultrasound and CT guided procedures. All X-Rays are performed on CR and DR System which is beneficial for lessening patients waiting time, radiation dose and simultaneous viewing of images by multiple users in the Hospital (PACS System). Tests are being provided by qualified personnel in accordance to ISO standards.



## EMERGENCY SERVICES 24/7

Patel Hospital Emergency service has a capacity of 15 beds, supported by professional and skilled medical and paramedical staff. Our services are operational round the clock to cater all the emergency requirements of patients. The department is fully equipped for treating critical patients, has the facility and expertise of intubation and resuscitation. In order to raise the effectiveness of rescue efforts a well-defined emergency management system has been established which includes enhanced first aid on the site and upgraded overall coordination amongst the staff of the hospital involved in coping with emergency conditions.

## NUTRITION AND DIET CONTROL

Nutrition section also working under the supervision of Food Service Department (FSD) covers both In-Patient and Out-Patient services to provide dietary care, Clinical Dietician design food and nutrition programs and plan menus of the patients according to their therapeutic needs.

## OPERATION THEATRES

Patel Hospital has four Operation theatres comprising of three main and one minor operation room. The facility has a post anesthesia care unit (PACU) as well and is well equipped 24/7 availability of services with In house anesthesia and surgical cover.

## OUT PATIENT DEPARTMENT

Patel Hospitals provides 12 hours OPD services starting from 9:00 am till 9:00 pm evening. Our OPD consultants are recognized among the best doctors in the city providing quality healthcare services. We offer services of 33 specialties with almost 100 doctors giving their services to the ailing humanity, supported by experienced and trained staff.

## EXECUTIVE AND VIP ROOM

These rooms are designed to take care of your comfort needs with features like separate attendant area (only available in Executive Room), separate kitchen (only available in Executive Room), LED T.V, couches, attached bathroom and a wardrobe facility, basically high class ambiance guaranteed.

## GYNAE ENDOSCOPY FACILITY

The Department of Obstetrics & Gynae endoscopy is a teaching unit. It offers premium care to patients under the best gynecologist & obstetrician. The Department has well established hygienic patient care setup, which is monitoring regularly. The department is managing emergency 24/7 & provides emergency obstetrics & Gynae services. Gynae endoscopy department provides treatment for General Gynaecology, Gynae Laparoscopic Surgery, Urogynecology, Infertility; services also include provision of guidance about birth control.

## CLINICAL LABORATORY

Clinical Laboratory Services offers 24/7 services that cater to the needs of inpatients, outpatients and outside referrals by providing the best possible and modern diagnostic facilities at Patel Hospital. The Diagnostic Laboratory Department is ISO 9001:2015 certified and internationally recognized with external quality assurance program RIQAS. We also actively participate in College of American Pathology (CAP) surveys and programs. Highly qualified faculty and skilled technical staff are engaged in providing comprehensive Hematology, Microbiology, Clinical and Special Chemistry, Molecular Biology, Histopathology & Cytopathology; and Blood Bank services.





## PHARMACY 24 HOURS

24/7 Inpatient services given to both associate and corporate patients, covering the entire hospital supported by a complete online system and a backup of a fully functional Pharmacy store. The items are dispatched under the First in First out (FIFO) system. We have competent team of pharmacists and also technicians who are knowledgeable and capable about the medicines we dispense.

## PHYSIOTHERAPY AND REHAB

The department comprises of experienced and qualified physiotherapists with the help of four internees' providing relief to those who arrive at our Hospital with pain and entangled mobility. The department's personnel are highly trained to work with latest modalities and hands on techniques.

## CORONARY CARE UNIT

It is our dedicated unit for provision of state of the art 24/7 care for cardiac patients. It's a six bedded facility, with ECG, CPAP and BIPAP facilities. On call doctors are always available inside the unit.

## EYE DIAGNOSTIC SERVICES

The Department offers advanced equipment to help evaluate and also access the diseases that affect the eye of the human. Eye Diagnostic services includes OCT, FFA, ICGA, Angiography, Fundus Photography, Visual field test, pachymetry and B-scan.

## INTENSIVE CARE UNIT

A purposely built ICU with the capacity of fourteen beds and ten ventilators, medical and surgical patients are both catered here. We are giving comprehensive care to critical patients based on advanced diagnostic technology and standard protocol treatment according to updated guidelines. There is almost 100% recovery rate of free flap (plastic surgery) patients.

## PATEL INSTITUTE OF NURSING AND ALLIED HEALTH SCIENCES (PINHAS)

One of the proud pillars of Patel Hospital, it offers courses ranging from technician level to Post graduation. Facilities include Library, Skill Lab and Computer Lab etc.

## SPEECH THERAPY CLINIC

Patel Hospital has a dedicated speech therapist who conducts clinics. We provide the facilities of treating children with grammatical problems, dysarthria (muscle impairment), speech and communication disorders. Patel hospital; Cochlear implant and Cleft palate patient had made good progress in speech and showed phonological awareness and literacy development at an age-appropriate level. However, a small number of children had phonological awareness and literacy delay.

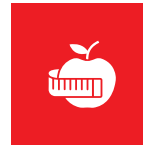

## THE WONDERS OF ENDOSCOPY

**I**t was a usual day, when Mr. Rehan came back from the office at around 5:30pm. He was healthy with only history of some vague pain in epigastric region. The doctor had prescribed him some pain killers for his joint related condition.

Two hours later, he felt nauseous and soon had an episode of vomiting. He thought it was just indigestion but 30 minutes later had another episode of vomiting full of blood. The alarming situation brought him and his family under a lot of stress.

The family brought the patient to the hospital in a panicky situation. He was unwell and his initial assessments showed him to be vitally unstable with low blood pressure and high pulse. Initial lab assessment showed low hemoglobin and he was admitted in the monitoring unit.

He was intubated and mechanically ventilated, and we planned to get an endoscopy soon. After almost 12 hours in the ICU, an endoscopy was done that showed a visible vessel with active bleeding. Hemostasis was secured after therapy and the bleeding had stopped.

A few hours later, the patient started to become stable vitally and was planned to be extubated.

He remained well and his family considered this to be no less than a miracle looking at what the initial presentation was. Upon knowing it all, the patient believed that he got a new life.

There are certain incidents in life that make you worried and you are left hopeless. Remember one thing, there is always a ray of light in darkness.

# THE MYTHS OF DIALYSIS, ENDED

Life in the elderly age gets very elusive when it comes to health. We frequently get careless about it and forget how important it is to take care of it. Mr. Ashrafallah Khan, our 60 years old male patient was a diabetic patient for over 15 years and was on insulin from the beginning. However, this started getting worse when his foot got wounded which caused him to develop Kidney Disease.

He visited multiple doctors for this case but his health was unable get stable. The family then decided to visit Patel Hospital on relatives advice to discuss this issue when they noticed the wound was getting worse day by day and started affecting his health, causing diarrhea and shortness of breath.

The family went through multiple counselling sessions from the doctors but the situation went in dire straits when the patient developed discomfort along with severe shortness of breath. Doctors had to shift him immediately to ICU and recommended dialysis to the patient but with thoughts of life long impartibility, his family was strictly against that option.

Without compromising on patient's health conditions, doctors managed to stabilize the conditions of the patients while the family was being counseled. After multiple opinions from family doctors as well. Finally the family agreed on the dialysis sessions which had a marvelous impact in making his health reach back to stability. After which the patient was shifted back to general ward and no longer required any additional dialysis sessions.

Mr. Ashrafallah was one of the cases of Acute Kidney Injury, a condition in which dialysis sessions is done as per need and not on permanent basis. The patient stayed in the general ward for a few days for observation after which he got discharged. The family was very happy to see their father healthier again and returned home with a changed mindset which was no longer under the influence of stereotypical thinking which people generally create, shattering myths of "Once a patient has been put on Dialysis, he has to keep on having them forever".

# SPASMS & TREATMENT THROUGH INCUBATION

An 18 year old girl, student, came to the Emergency Department of Patel Hospital with the complains of neck, back pain and difficulty opening mouth for 2 days. There were no spasms. She had visited a doctor a day before and received symptomatic treatment.

After thorough history taking and examination, with no forth-coming history of any recent injury she was advised ICU admission.

The impression of tetanus was discussed and the usual course, probability of worsening explained to the family. Due to restricted mouth opening and anticipating worsening of the condition she was advised elective intubation however intubation was unsuccessful due to restricted mouth opening. Again, on the very day of admission a very long session of counseling was held after which the family agreed for tracheostomy.

The patient remained stable the next day however on the third day of admission she developed spasms and late in the evening was put on ventilatory support due to protracted spasms.

The family became very apprehensive regarding the patient being put on ventilator and worsening of her condition during hospital stay. The family was again explained and counseled by the primary

treating physician that although the patient has worsened with regards to developing spasms and being put on ventilator it was not unexpected and God-willing with continued treatment she shall make a full recovery.

The patient improved and was taken off ventilator the next day. The subsequent 19 days were uneventful with gradual tapering of medications and steady improvement. The patient was discharged after tracheostomy reversal.

She was doing well on subsequent follow-ups in the out-patient department.

# THE NIGHTMARE OF GUILLIAN-BARRE SYNDROME

The destiny of the world is determined less by the battles that are lost and won than by the stories it loves and believes in. It all began when an 8 year old male child developed sudden onset fever followed by lower limb tingling and numbness. He could walk but with limping gait and which they thought was due to a pinched nerve. Soon after that child developed cough associated with chest congestion for which they went to a tertiary care hospital and was treated on the lines of pneumonia. After 2 to 3 days lower limbs started getting weak with decrease in power so rapidly that patient just collapsed onto the floor and choked while getting out of bed, so was taken on ventilator support and referred to Patel Hospital for further neurological workup. It was a nightmare as child was losing his independence. The fear that was felt on arrival of a child at night who is having very low power, absent reflexes in all four limbs with no gag and cough reflex is indescribable. Patient is taken on ventilator support and family was told to expect the worst.

The nightmare of surviving from one day to the next started. After neuro consultation, with high suspicion of Guillain-Barré Syndrome, plasmapheresis was planned. Parents had no idea about this autoimmune disorder that destroys myelin sheath that insulates mild weakness to full blown paralysis which has no definitive cure. Patient remained on ventilator and acquire resistant infections which further add to the sufferings of the innocent child. After 5 cycles of plasmapheresis, wean off trial was given as some improvement in power and reflexes was noted but he couldn't make up and reintubated with similar choking episode.

It was a dark and gloomy night. He never abandoned his hope despite of miserable infirmity. After 2 days child was successfully extubated. EMG and NCV was done which confirms the diagnosis of Guillain Barré Syndrome. With proper physiotherapy and tender care he was able to lift his arms and legs within a week.

Giving up was not an option for him. He tried to make every day more meaning full and valuable with all the support and love that carry him throughout this journey. After 2 weeks he was able to sit independently, taking oral diet and discharged on long term physical and occupational therapy. There have been many ups and down during this ailment, tears and laughter, set back and progress with a lot of dogged perseverance.

Now Hassan has improved his speaking skills and now recognizes the names of things he sees around him. He is more confident than ever and his parents are happy to see and hear their son speaking fluently.

# INDEPENDENT AUDITOR'S REPORT TO THE TRUSTEES

## OPINION

We have audited the financial statements of **Patel Foundation (Patel Hospital)**, which comprise the statement of financial position as at June 30, 2019 and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of **Patel Foundation (Patel Hospital)** as at June 30, 2019 and its financial performance and its cash flows for the year then ended in accordance with approved accounting and reporting standards as applicable in Pakistan as mentioned in note 2.2.

## BASIS OF OPINION

We conducted our audit in accordance with the International Standards on Auditing (ISAs) as applicable in Pakistan. # NOTES TO THE FINANCIAL STATEMENTS

For the year ended June 30, 2019

## 1. Nature and status of business

Patel hospital (herein after referred as "Hospital"), was established in Karachi, Pakistan on 24<sup>th</sup> November 1999 under the Trust Act, 1882 as a trust. The principal business activity of the hospital is to provide quality medical and healthcare facilities at affordable charges.

## 2. Summary of significant accounting policies

### 2.1. Accounting convention

These financial statements have been prepared under the "historical cost convention".

### 2.2. Statement of compliance

These financial statements have also been prepared in accordance with "Guideline for accounting and reporting for Non-Government (NGOs) and Non-Profit Organizations (NPOs)" issued by ICAP and in case requirements differ, Financial Reporting Standards for Small and Medium-Sized Enterprises shall prevail.

### 2.3. Critical accounting estimates and judgments

The preparation of financial statements in conformity with the requirements of approved accounting standards as applicable in Pakistan requires management to make judgments, estimates and associated assumptions that affect the application of policies and the reported amounts of assets & liabilities and income & expenses. The judgments / estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the result of which form the basis of making judgments about the carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on periodic basis. Revision to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgments made by management in the application of approved accounting standards, as applicable in Pakistan, that have significant effect on the financial statements and estimates with a significant risk of material adjustments in the future years are as follows:

- a) determining the residual values, useful lives and pattern of flow of economic benefits of property, plant and equipment's;
- b) Impairment of financial assets;

Other areas, if any, where estimates and judgments involved are disclosed in respective notes to the financial statements.

### 2.4. Property plant & equipment

#### 2.4.1. Owned assets

Property plant & equipment are stated at cost less accumulated depreciation value except for freehold land, which is stated at cost. Depreciation is charged to profit and loss account by applying the reducing balance method at the rates specified in the property plant & equipment note.



# NOTES TO THE FINANCIAL STATEMENTS

For the year ended June 30, 2019

Depreciation on additions during the year is charged from the month the asset is available for use while depreciation on disposal is charged up to the preceding month of disposal.

Normal repairs and maintenance are charged to profit and loss account as and when incurred. Major renewals and improvements are capitalized.

Gain or loss on disposal of property plant & equipment is recognized in the period of disposal.

## 2.4.2. Leased assets

Leased assets are stated at an amount equal to the lower of its fair value and the present value of minimum lease payments at the inception of the lease, less accumulated depreciation and impairment losses, if any.

## 2.5. Intangible assets

Intangible assets are stated at cost less accumulated amortization and accumulated impairment losses. The depreciable amount of intangible asset is amortized on a systematic basis over the estimated useful lives using the reducing balance method.

## 2.6. Impairment of assets

At each balance sheet date, the hospital reviews the carrying amounts of its assets for indications of impairment loss. If the recoverable amount of an asset or cash generating unit is estimated to be less than the carrying value, the carrying value of the asset is reduced to its recoverable amount. Impairment losses are recognized as an expense immediately.

## 2.7. Stock in trade

These are valued at lower of cost and net realizable value applying the weighted average cost.

Stock-in-transit is stated at invoice value plus other charges paid thereon to the balance sheet date.

Net realizable value signifies the selling prices prevailing in the market less selling expenses incidental to sale.

## 2.8. Trade debts

Trade receivables are carried at the original invoice amount. Bad debts are written off when identified.

## 2.9. Taxation

### Current

The foundation has been approved as a non-profit organization under clause 2(36) of the second schedule to the Income Tax Ordinance 2001 vide letter # CIT/COS-V/2007/358 dated 11-07-2006.

Further, under clause 11(A) (IX) of part IV of Second Schedule to the Income Tax Ordinance 2001, Foundation being a non-profit Organization approved under clause 36 of Section 2 of the Income tax Ordinance is also exempt from minimum tax.

# NOTES TO THE FINANCIAL STATEMENTS

## 2.10. Cash and cash equivalents

Cash and cash equivalents include cash in hand, balances with treasury banks and balances with other banks in current and deposit accounts.

## 2.11. Financial instruments

All financial assets and liabilities are recognized at the time when the firm becomes a party to the contractual provisions of the instrument. Any gain or loss on de-recognition of the financial assets and financial liabilities are included in the net profit / loss for the period in which it arises.

## 2.12. Foreign currency transactions

Transactions in foreign currencies are converted in Pak rupees at the rates of exchange prevailing on transaction date. Any exchange gains and losses are recognized in the profit and loss account.

## 2.13. Provisions

Provisions are recognized when the firm has a present legal or constructive obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation and a reliable estimate of that amount can be made.

## 2.14. Zakat & Donations

Zakat that is received or becomes receivable are recognized in the Fund Account during the period in which these are received or become receivable and utilized strictly in accordance with Shariah.

Hospital receives "Donations" from its Associates and Well-wishers for a particular project or for purchase of specific equipment required in any department. These donations are recognized as donated capital in Fund Account. These "Donations" are not utilized to meet hospital's operational expenses.

Where receipts are in excess of the actual expenses or vice-e-versa, the balance is carried forward as fund balance

## 2.15. Revenue recognition

Revenue is recognized when it is probable that the economic benefits associated with the transaction will flow to the hospital and the amount of revenue and the associated cost incurred or to be incurred can be measured reliably.

- a) Clinical, cafeteria and nursing school's income are recognized at the time when services are rendered;
- b) Sale of goods is recognized when the goods are delivered and the risks and rewards of ownership have passed to the customer.
